Aims of the Summer School

The Summer School will give researchers from all over the world the opportunity to learn more about current topics of IT Law and Legal Informatics and to participate in research through their own contributions. It is aimed at Law and Legal Informatics graduates as well as graduates from other areas of study to which IT Law and Legal Informatics are relevant. Interest in cross-disciplinary and international collaboration is a prerequisite for participation.

The four topics will be dealt with as four separate units, each lasting 2 days. The first day of each unit will consist of an introduction to the topic by a top-class lecturer. The second day will be dedicated to the work of the participants: each participant will present his topic orally to the rest of the group and this will then be discussed by the participants.

The extensive social program will give the participants the opportunity to get to know one another in an informal setting. During our excursions, we will explore the Saarland and the surrounding region. We will visit a UNESCO World Heritage Site as well as other highlights.

Application Process and Participant Selection

The number of participants is limited to 28. Participation in the Summer School follows successful application and receipt of confirmation of participation from the organisers.

Deadline for applications: 28th May 2017.

Applications submitted after the deadline may be considered if places are still available.

Your application should contain the following:

- the **Application Form** from the website;
- a **tabular CV**;
- a **short statement** setting out your qualifications and why you are interested in taking part in the Summer School;
- **2 proposals** for subjects for your own contribution (800 to 1,500 words each). Please indicate which one is your preferred choice. The subjects must be from 2 of the 4 topic areas covered by the Summer School.

Participation and costs

There is no charge to participate in the Summer School although we will have to ask participants to contribute to the cost of excursions (see the program). In addition, participants agree to their contribution being published in the Summer School proceedings and assign the necessary copyright interests to the publisher.

Travel arrangements

- **Saarbrücken Airport** has regular direct connections to Hamburg and Berlin-Tegel
- High-speed trains connect Saarbrücken to **Paris (Gare de l'Est)** in less than two hours
- Direct trains connect Saarbrücken to **Frankfurt airport** train station
- Other nearby airports include **Luxembourg** and **Metz**
